World Skin Health Day Terms & Conditions

1. The proposed activities must promote skin health and be in line with the missions of the International League of Dermatological Societies (ILDS) and International Society of Dermatology (ISD).
2. Only ILDS and ISD members are eligible to participate in World Skin Health Day and members must be up to date with their membership fees. However, we encourage ILDS and ISD Members to collaborate with a broad range of stakeholders in their activities.
3. The ILDS and ISD cannot provide financial or administrative support for member initiatives.
4. World Skin Health Day logo
The World Skin Health Day logo can only be used by societies who have applied and been accepted to participate in World Skin Health Day. The following guidelines on use of the logo apply:
 - a. Permission is for one-time use – i.e. for use on materials relating to the activity that the society has submitted in their application form and relates to a particular year. Re-approval is required for activities taking place the following year.
 - b. The logo should not be altered (for example with respect to the colour or aspect ratio etc).
 - c. The logo should not be used at a size less than 30mm wide.
 - d. The logo can only be used for the activity agreed.
 - e. The logo cannot be used for any commercial purposes.
 - f. Publicity materials (e.g. printed literature, signage, etc) should include the statement, “World Skin Health Day is presented under the auspices of the International League of Dermatological Societies and the International Society of Dermatology.”
 - g. The joint ILDS/ISD logo block should not be used at a size less than 30mm wide.
5. Societies should submit a final report with photos, where possible, within three months of the completion of their activity. Please ensure that you have either verbal or written consent from participants or their parents if they are under the age of 18. The report should include:
 - a. Description of the activity/event e.g. what happened
 - b. Who attended
 - c. Number of participants (with categories if appropriate, e.g. dermatologists, other health care providers, patients, public)
 - d. Publicity (e.g. media uptake, social media statistics)

We agree to the above terms and conditions and submit our proposal to take part in World Skin Health Day 2021. This form has been completed with the full authority of the officers of the applicant society.
